



**Instant Game – OK 50 – \$30,000 Poker Showdown
Summer 2007
PROMOTIONAL PROCEDURES**

Purpose

The purpose of this document is to provide a clear understanding of the Oklahoma Lottery's \$30,000 Poker Showdown promotion. The instant game component of the promotion is governed by the Oklahoma Lottery Commission (OLC) Rules.

Eligible Trip Winning Tickets

A trip winning Poker Showdown ticket reveals a straight flush (5 cards in a sequential row of the same suit) in a single hand. Trip winning tickets must be validated and claimed at the Oklahoma Lottery Headquarters at 3817 N. Santa Fe Ave., Oklahoma City, OK 73118.

Prizes

Twenty five (25) trips for two to Las Vegas, Nevada

- \$1,500 travel voucher to Ski and Sport travel agency
- \$250 cash for spending money
- \$715 for Federal and State withholdings provided by OLC
- Total Estimated Value is \$2,465

Redemption

All trip winning tickets will be awarded a \$1,500 travel voucher to Ski and Sport travel agency. This voucher is good for 12 months from the date the ticket is validated and prize is claimed. Voucher may be used toward any service offered by the agency. Voucher does not have to be used for a trip to Las Vegas nor must it be used on a single trip. Voucher has no cash value and any unused portion at the end of 12 months cannot be exchanged for cash.

Upon validation of a trip winning ticket, each winner will receive the following prizes and documents:

- Travel Voucher to Ski and Sport travel agency
- Check for \$965 (\$250 for spending money, \$616 for Federal tax withholdings, and \$99 for State tax withholdings)
- Voucher, cash, and tax withholdings acceptance form
- General waiver form

Oklahoma Child Support Compliance and Other Offsets

During validation, Oklahoma Child Support compliance and other required offsets will be verified through the Oklahoma Department of Human Services or other applicable departments. If a winner is found to owe child support or other offsets, dollars owed will be subtracted from all cash amounts associated with the prize. If those monies do not cover the debt, the balance will be subtracted from the value of the trip package itself and the remaining cash value (if any) will be awarded to the winner in place of the trip. Estimated trip value is \$2,465.

General Rules

- Only persons 18 years of age or older are eligible to win.
- Winners will be required to complete a claim form, general waiver form, and provide two forms of identification to the Oklahoma Lottery.
- By claiming a prize in this promotion, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, www.lottery.ok.gov.
- The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
- Prizes pictured in game materials are for illustrative purposes only.
- Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
- Each person winning a trip agrees by the act of purchasing a \$30,000 Poker Showdown Scratchers to be bound by these Instant Game Promotion Procedures of the Oklahoma Lottery.
- Once the prize package has been claimed by the recipient the winner is the sole owner of that package. The Oklahoma Lottery is not responsible for the subsequent use or delivery of any travel services.
- The Oklahoma Lottery makes no express or implied warranties of any kind with respect to the safety, appearance or performance of any prize offered.
- These Instant Game Promotion Procedures may be modified at any time at the sole discretion of the Oklahoma Lottery.
