Entry Submission Methods- Entries will be valid for the entire promotion. Only one entry allowed per person.

- 1. <u>Mobile Club Text Message</u>: Players may enter via Mobile Club by texting LOTTO500 to 44622.
- 2. <u>Oklahoma Lottery Website</u>: Players may visit the Oklahoma Lottery website, <u>www.lottery.ok.gov</u>, and enter the required information for a valid entry.

Drawing Information

1. Drawing Details

The Prize Drawings will be held at the Oklahoma Lottery headquarters on an hourly basis between the hours of 9a-4p each day of the promotion. Only the promotions manager and either the security official or the internal auditor should be present during each drawing. A computer based automated drawing system will be used to execute the official drawing. Only one (1) winner will be drawn every hour from the submissions to serve as the prize winner. No alternates will be drawn; if a prize cannot be awarded, the prize will go unclaimed.

Winners will then be contacted by the Oklahoma Lottery for prize fulfillment purposes.

General Rules and Procedures

- 1. All prize winners must be 18 years or older. Winners will be required to provide proof of age. Winners must be residents of Oklahoma.
- 2. Winner(s) will be notified via phone of their winner status using the contact information provided from submission after all validation and verification has taken place.
- 3. Players can only win one prize during this promotion.
- 4. By submitting an entry in this promotion, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, www.lottery.ok.gov, and at authorized OLC retailers.

The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
