**Entry Submission Methods**

1. Mobile Club Text Message: The only way to enter a Mobile Club promotion is to reply the specified short code to 44622 for a chance to win.

**Drawing Information**

**1. Drawing Details**

The Prize Drawing will be held at the Oklahoma Lottery headquarters on the dates specified for each drawing. Only the promotions manager, security official and the internal auditor should be present during the drawing. A computer based automated drawing system will be used to execute the official drawing. A total of 3 entries will be drawn from the submissions to serve as the prize winner and alternates for each drawing. Entry one will be awarded prize and entries two and three will serve as alternates in case a winner is disqualified.

Winners will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn and subsequently verified for validity.
