Text the specified short code, LOTTOCASH, to 44622 for your chance to win prizes listed below.

**Promotion Dates**

**Entry Submission Methods**

1. Mobile Club Text Message: The only way to enter a Mobile Club promotion is to reply the specified short code to 44622 for a chance to win.

**Prizes**

1. **Twenty-eight (28) winners will receive \$100 Cash Prizes-one winner per day.**

**Drawing Information**

**1. Drawing Details**

The Prize Drawing will be held at the Oklahoma Lottery headquarters on the date specified for each promotion. Only the promotions manager, security official and the internal auditor should be present during the drawing. A computer based automated drawing system will be used to execute the official drawing. A total of 3 entries will be drawn from the submissions to serve as the prize winners and alternates. Entry one will be awarded the daily prize and entries two and three serve as alternates in case a winner is disqualified.

Winners will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn and subsequently verified for validity.

**General Rules and Procedures**

1. All prize winners must be 18 years or older. Winners will be required to provide proof of age.
2. Winner(s) will be notified via phone of their winner status using the contact information provided from submission after all validation and verification has taken place.
3. By submitting a text message, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, [www.lottery.ok.gov](http://www.lottery.ok.gov), and at authorized OLC retailers.
4. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
5. Prizes pictured in game materials and on the Lottery website are for illustrative purposes only.
6. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
