Entry Submission Methods

Mobile Club Text Message

Entrants must text the key word "LOTTOTHUNDER" to the number 44622 to enter. Entrant must be a valid and active member of the Oklahoma Lottery Mobile Club at the time of the drawing, must be 18 or older and an Oklahoma resident to be eligible to win a prize. If an entrant opts out of the Mobile Club any time during the promotional period, their entry is no longer valid and will be disqualified if drawn as a winner or an alternate in the prize drawing.

Entry Period

The entry period for this promotion is **November 8, 2017 to February 21, 2018**. LOTTOTHUNDER text must be received within promotional period to qualify for this promotion. Text entry is good for all drawings.

Drawing Information

The prize drawing will be held at the Oklahoma Lottery headquarters. During the drawing, only the drawing representative, security official and an accounting representative will be present. All submitted entries will be digitized and uniquely numbered for the official drawing. A computer based automated drawing system will be used to execute the official drawing. For each drawing, a designated number of entries will be drawing to serve as winners and alternates to cover the total number of winners needed for that entry period. Please see draw schedule above to determine the amount of entries that will be draw as winners. All other entries drawn will be assigned as alternates in the event a winner or winners cannot claim their prizes. Winners will be contacted by the Oklahoma Lottery for prize fulfillment purposes.

Promotion Specific Rules

- 1. Players may only win one prize per drawing
- 2. Players may only enter this promotion once
- 3. Players must live in the state of Oklahoma at the time of the drawing
- 4. Players must be an active member of the Oklahoma Lottery mobile club in order to win prize
- 5. The OKC Thunder home game tickets received by winners will be pre-selected by the Oklahoma Lottery based on the order in which winners are drawn.

General Rules and Procedures

- 1. All winners must be 18 years or older. Winners will be required to provide proof of age.
- 2. Winner(s) will be notified via phone of their winning status using the contact information provided on contact information provided via text message system. After initial contact, winner must complete the OLC validation process within five (5) business days or winner will automatically forfeit the prize. A reminder phone call will be initiated at the end of the 4th day notifying them that they have less than 24 hours until their prize is fortified. Final awarding of prize will take place after all validation processes have been completed.

If a winner cannot be reached by phone a voicemail (if possible) will be left indicating that the winner has five (5) business days to contact the OLC or the prize will be forfeited. Once the winner contacts the OLC, then they will have an additional five (5) days to complete the OLC validation process. A reminder phone call will be initiated at the end of the 4th day notifying them that they have less than 24 hours until their prize is fortified. Final awarding of prize will take place after all validation processes have been completed.

If a prize has a time sensitive element to it (i.e., event or sporting tickets), the Claims Coordinators may decrease the contact deadline or validation deadline to a period not less than 24 hours.

Any other variation to the communicated deadline must have an approval by the Director of Marketing and Administration.

- 3. By submitting an entry, each player authorizes the Oklahoma Lottery to release winner information to various media sources. Winners' names and pictures will also be posted on the Oklahoma Lottery website (www.lottery.ok.gov) and digital screens at retailers and can be used at authorized OLC retailers. The winner hereby consents to the reasonable use by the Oklahoma Lottery of the winner's photographs, voice, likeness, and/or image, contents of the entry form and the name and age of the winner without any further notice or compensation for any future promotional activity.
- 4. The Oklahoma Lottery reserves the right, at its sole discretion, to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
- 5. Prizes pictured on point-of-sale materials and on the Lottery website are for illustrative purposes only.
- 6. Winners of cash and merchandise prizes valued over \$600 will be issued a W2-G tax form. Cash prizes over \$5,000 are subject to federal and state tax withholdings at the time of prize awarding. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.

 X Get Y promotions.
- 10. Former employees of the Oklahoma Lottery are permitted to participate in promotions. If a former employee is selected as a winner of a promotion, they are required to speak with the security team prior to prize being awarded.

- 11. The Oklahoma Lottery, at its sole discretion, reserves the right to terminate any promotional drawing if the number of entries, for that promotion, does not exceed 100. The subsequent prizes may then be offered in a future Oklahoma Lottery promotion.
- 12. No other tickets or entries are eligible for this promotion, including Scratchers games, online games, sample-void tickets, altered or stolen tickets, postcards, any canceled ticket or any likeness of an authentic ticket.
- 13. The Oklahoma Lottery will not provide any assurance and/or verification of receipt of any entry submitted by any player or promotion participant.
- 14. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
- 15. Each person entering this promotion agrees by the act of participation to be bound by these promotional procedures of the Oklahoma Lottery.
