Prizes

1. Four (4) Summer Get-a-way travel vouchers

1. **Prize:** Each winner will receive one travel voucher valued at a maximum of \$2,500.
2. **Specifications:** Each travel voucher is valid for one year from the date awarded. Winners may pick their own travel package. If the trip the winner plans exceeds the \$2,500 voucher, the winner is responsible for the remainder of the balance over the \$2,500. If the trip planned does not meet the \$2,500 maximum, the difference will be credited for future use within the 12 month period. Any portion of the travel voucher not used within the 12 month expiration will be forfeit.
3. **Fulfillment:** Winners will work with Big Sky Tours to make travel arrangements. The trip fulfillment shall include the scheduling and coordination of all travel, hotel accommodations, tickets and ground transfers to and from the hotel, if needed.

Entry Submission Methods

Postal Mail

An official entry consists of an entry ticket printed from an eligible purchase with information completed and mailed to the Oklahoma Lottery headquarters. A complete name, address, telephone number, email (optional), signature and checked age verification box must be provided on the entry. Entries must be submitted in an envelope. Multiple entries in an envelope will be accepted. Each entry will be valid throughout the duration of the promotion. The Oklahoma Lottery is not responsible for lost, late, misdirected, damaged, incomplete, altered, illegible or postage-due mail. Valid entries must be received in the offices of the Oklahoma Lottery by end of day on the final day of the entry period to be included in the selection process.

Deposit at OLC Headquarters

Players may enter the promotion by depositing their entries with the Claims Department at the Oklahoma Lottery Headquarters. Oklahoma Lottery employees cannot hand deliver entries given to them from any participating individual and any entry delivered in such manner will be disqualified.

Entry Period

Entries must be received prior to the draw date of April 30, 2014 to be eligible for this promotional drawing.

Drawing Information

The Prize Drawing will be held at the Oklahoma Lottery headquarters. During the drawing, access to the drawing room will be limited and a log will be maintained of all OLC employees present for the drawing and their roles. Only the drawing representative, security official and an accounting representative should be present during the drawing. All submitted entries will be digitized and uniquely numbered for the official drawing. A computer based automated drawing system will be used to execute the official drawing. A total of eight (8) entries will be drawn from the submissions to serve as the prize winners and alternates. Of the selected entries, entry 1 thru 4 will be awarded the prizes and entries 5 thru 8 will serve as alternates in case the winner(s) cannot claim their prize.

The drawing representative will record the drawn ticket and entrant's information for all entries. Winner will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn and subsequently verified for validity.

General Rules and Procedures

1. Player's may only win one prize during this promotion.
2. All prize winners must be 18 years or older. Winners will be required to provide proof of age and maybe required to show proof of purchase.
3. Winner(s) will be notified via phone/mail or email of their winning status using the contact information provided on the entry ticket/online submission. Final awarding of prize will take place after all validation processes have taken place.
4. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, www.lottery.ok.gov, and at authorized OLC retailers.
5. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
6. Prizes pictured on point-of-sale materials and on the Lottery website are for illustrative purposes only.
7. Winners of cash and merchandise prizes valued over \$600 will be issued a W2-G tax form. Cash prizes over \$5,000 are subject to federal and state tax withholdings at the time of prize awarding.
