#### **Eligibility**

#### **Entry Submission Methods**

<u>Postal Mail</u> - An official entry consists of an entry ticket from an eligible purchase with information completed and mailed to the Oklahoma Lottery headquarters. A complete name, address, telephone

number, email (optional) and signature must be provided on the entry. Entries must be submitted in an envelope. Multiple entries in an envelope will be accepted. Each entry will be valid throughout the duration of the promotion. The Oklahoma Lottery is not responsible for lost, late, misdirected, damaged, incomplete, altered, illegible or postage-due mail. Valid entries must be received in the offices of the Oklahoma Lottery by end of day on the final day of the entry period to be included in the selection process.

# **Drawing Information**

The Prize Drawing will be held at the Oklahoma Lottery headquarters. During the drawing, access to the drawing room will be limited and a log will be maintained of all OLC employees present for the drawing and their roles. Only the drawing representative, security official and an accounting representative should be present during the drawing. All submitted entries will be digitized and uniquely numbered for the official drawing. A computer based automated drawing system will be used to execute the official drawing. A total of four (4) entries will be drawn from the submissions to serve as the prize winner and two (2) alternates. Of the selected entries, entry 1 and 2 will be awarded the prizes and entries 3 and 4 will serve as alternates in case the winner(s) cannot claim their prize.

The drawing representative will record the drawn ticket and entrant's information for all entries. Winner will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn and subsequently verified for validity.

#### **General Rules and Procedures**

- 2. All entries submitted for the NBA All-Star 2014 Drawing are eligible for the NBA Finals 2014 Drawing (prize details for the NBA Finals 2014 Drawing to be determined at a later date).
