

OKC Thunder Scratcher Jersey Redemption PROMOTIONAL PROCEDURES

Purpose

The purpose of this document is to provide a clear understanding of how a jersey can be redeemed from winning a "jersey" prize on the Oklahoma Lottery OKC Thunder Scratcher. The instant game component of the promotion is governed by the Oklahoma Lottery Commission rules.

Instant Game – OK 118 – Oklahoma City Thunder Scratcher

Scratcher Launch Date: December 2, 2008



Promotion

If a player reveals a "jersey" symbol in the Free Throw box on an Oklahoma City Thunder instant ticket, the player instantly wins an Oklahoma City Thunder player jersey.

Prize

- One (1) OKC Thunder Jersey
 - <u>Prize Specifications</u>: one (1) Desmond Mason *or* Kevin Durant with Oklahoma City Thunder jersey in large or extra large; the jerseys are NBA Swingman Home Jerseys in white. (value \$100.00)
- A total of 360 jersey winning tickets will be available in the Oklahoma City Thunder Scratcher

Redemption of Prizes

- To redeem the "jersey" prize a person must have a valid "jersey" winning Oklahoma City Thunder Scratcher.
- A winner may redeem their prize at the Oklahoma Lottery Headquarters located in Oklahoma City, OK.
- A winner may choose to mail in a winning ticket at the address below. If so, the jersey of the winner's choice, if available, will be mailed to the winner within fourteen (14) business days from the date the winning ticket is received at the Oklahoma Lottery headquarters.

Box 548810 Oklahoma City OK 73154-8810 Due to the late creation of the Oklahoma City Thunder NBA team and their merchandise, all authentic Thunder jerseys are currently in production and will not be available until January 15, 2009. A winner may either hold their "jersey" winning ticket until after January 15, 2009, or they may claim their prize now, knowing their jersey will be mailed when it becomes available.

Validation

- All winners must be 18 years of age or older.
- Proof of age will be required to redeem the "jersey" prize
- If a winner does not meet all required qualifications they will be disqualified.

Jersey Options

Winners will get to select between a Desmond Mason or Kevin Durant jersey in sizes large or extra large. The jerseys are on a first come first serve basis. If the jersey of the winner's choice is not available, they will be given a jersey from the remaining "jersey" prizes available.

General Rules

- Prize will be given as is and cannot be redeemed for any cash value.
- The Oklahoma Lottery is not responsible for submissions that are late, misdirected or incomplete. All submissions become the sole property of the Oklahoma Lottery and will not be returned.
