GAME PROMOTION PROCEDURES**

**Instant Game**

OK 237- Electric 8s

**Promotion**

Purchase a \$2 Electric 8s scratcher ticket and any non-winning Electric 8s scratcher ticket (“winning tickets” include any ticket that awards a free ticket as a prize) may be submitted online as an entry into the Summer Heat Retreat promotion to win the prize listed below.

**Promotion Dates**

August 16-September 5

**Drawing Dates**

September 6

**Prizes**

**1. Four (4) winners will get their Electric Bill Paid up to \$500**

Prize Detail:

- i. OLC will pay up to \$500 toward the winner’s most current electric bill.
- ii. Bill must be dated sometime within the promotional time frame.
- iii. The winner’s identification and bill contact information must match or other documentation must be provided to verify the winner’s electric bill ownership.
- iv. OLC will only pay the current electric bill value only, no past due amounts.
- v. If the winner’s electric bill does not exceed \$500, the remaining balance of the prize will not be awarded to the winner. There is no cash prize offered.

**Entry Submission Methods**

1. Oklahoma Lottery Website- Players may only enter the promotion via the Oklahoma Lottery website, [www.lottery.ok.gov](http://www.lottery.ok.gov). To enter, players must submit all of their contact information and the required codes from the entry ticket on the designated promotion webpage. Players must save their original scratcher ticket once it has been entered online. When entering online, players may be required to present the original entry ticket to complete the validation process if selected as a winner. If you enter online and cannot produce the ticket if you are selected as a potential winner, you will be disqualified.

**Drawing Information**

**1. Drawing Details**

The Prize Drawings will be held at the Oklahoma Lottery headquarters. During the drawings, access to the mailroom will be limited and a log will be maintained of all OLC employees present for each drawing and their roles. Only the promotions manager, security official, IT representative and the internal auditor should be present during the drawing. A computer based automated drawing system will be used to execute the official drawings. For this drawing, a total of eight (8) entries will be drawn from the online submissions to serve as four (4) prize winners and four (4) alternates. Of the selected entries, entries 1 through 4 will be awarded the prizes and entries 5 through 8 will serve as alternates in case a winner cannot claim their prize. Official drawing will be held September 6.

The promotions manager will record the drawn ticket and entrant's information for all entries. Winner will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn and subsequently verified for validity.

### **General Rules and Procedures**

1. Player's may only win one prize during this promotion.
2. All prize winners must be 18 years or older. Winners will be required to provide proof of age.
3. Winner(s) will be notified via phone/mail of their winner status using the contact information provided on the entry ticket/submission after all validation and verification has taken place.
4. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, [www.lottery.ok.gov](http://www.lottery.ok.gov), and at authorized OLC retailers.
5. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
6. Prizes pictured in game materials and on the Lottery website are for illustrative purposes only.
7. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.

The Oklahoma Lottery and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The Oklahoma Lottery is not responsible for entries that are late, misdirected or incomplete.
