

## Purpose

The purpose of this document is to provide a clear understanding of the promotional aspects of the Hot Lotto Sizzler February 2009 promotion. The online games components of the promotion are governed by the OLC Rules. The rules as well as these promotion procedures promote the integrity of the Oklahoma Lottery and ensure award winners are selected impartially and randomly.

# Online Game – Hot Lotto with Sizzler

# Promotion

Non-winning Sizzler purchases of \$2 or more can be entered on the Oklahoma Lottery website to win the prize described below.

\*The Hot Lotto Sizzler Cash Blast February 2009 Promotion is offered by participating lottery members of the Multi-State Lottery Association (MUSL).

### **Promotion Dates**

Entries are available from February 1-28, 2009. Entry submission will be accepted until Wednesday, March 4, 2009.

## Prizes

- 1. One (1) grand prize winner of one hundred thousand dollars (\$100,000)
  - a. This prize will be awarded to one winner from all entries received from all Member Lottery jurisdictions. There are multi states participating in this promotion.
- 2. Forty (40) winners of five hundred (\$500) dollars
  - a. These forty winners will be selected from the entries received from Oklahoma only players.

### Prize Fulfillment:

After the selected non-winning Hot Lotto with Sizzler tickets are drawn and validated by the MUSL, the fulfillment process will be initiated. The winners will then be contacted by the Oklahoma Lottery within ten (10) business days of the draw date to make prize delivery arrangements. Once delivery arrangements are made, the Oklahoma Lottery will payout the prizes within 10 business days.

# **Official Entries**

Players who purchase Hot Lotto with Sizzler plays totaling \$4.00 or greater total purchase price on a single ticket, and which do not contain winning plays in a Hot Lotto drawing, are considered qualifying purchases for this promotion. Players who do not purchase the Sizzler option on the Hot Lotto play purchase, or who purchase less than \$4.00 in total purchase price on a single ticket are not qualifying purchases for this promotion. Purchases for this promotion. Purchases prior to February 1, 2009 or after February 28, 2009 are not qualifying purchases for this promotion. Any tickets with plays that are winners in a Hot Lotto drawing are not qualifying purchases for this promotion.

### **Entry Submission Methods**

Entries for this promotion can only be submitted online.

 Oklahoma Lottery Website- Players may enter the promotion via the Oklahoma Lottery website, <u>www.lottery.ok.gov</u>. To enter players must submit all of their contact information (including name, mailing address, email address, phone number, date of birth), the state in which the ticket was purchased and the serial number from their qualifying ticket on the designated webpage. *The original non-winning ticket must be presented to the OLC to complete the validation process if selected as a winner.* Players must retain and present their qualifying ticket to claim a prize in this promotion. If players do not retain their qualifying ticket, they forfeit their prize and another winner for that prize will be selected.

#### Submission Deadlines and Requirements

- 1. Only entries received by 12:00 pm (noon) on Wednesday, March 4, 2009, will be eligible for the drawing. The Oklahoma Lottery is not responsible for entries received after the deadline. Entries received after the entry deadline date will be deemed ineligible for the drawing and will be destroyed. An entry is only eligible for this drawing and cannot be re-entered for any future drawings. Players may enter as often as they wish using valid entries. Players may only enter their qualifying purchases over the internet-any entries mailed or hand delivered to the lottery or MUSL offices will be discarded and will not included for any promotional prizes.
- 2. To enter players must submit all of their contact information (including name, mailing address, email address, phone number, date of birth), the state in which the ticket was purchased and the serial number from their qualifying ticket on the designated webpage, so that the owners of selected entries can be identified and contacted. Incomplete or illegible entries will be disqualified.

#### Winner Selection

- On the evening of March 4, 2009, MUSL staff will use a Random Number Generator to select forty (40) winners of five hundred (\$500) prizes for each Hot Lotto Member jurisdiction, and one (1) grand prize winner of one hundred thousand dollars (\$100,000) from all entries received from all Member Lottery jurisdictions. MUSL staff will also select ten (10) additional entries per jurisdiction as potential replacement winners for the five hundred dollar (\$500) prizes, and an additional five (5) additional entries for potential replacement winners of the one hundred thousand dollar (\$100,000) prize if any of the originally selected winning entries are non-qualifying, the players cannot present the winning ticket, or otherwise fail to properly claim their prizes
- 2. The drawing will be held under the supervision of the MUSL Drawing Manager and an independent auditor. All drawings will be videotaped. All MUSL Drawings are public events. Persons interested in attending drawings are invited to receive detailed information by contacting the Multi-State Lottery Security in Urbandale, Iowa at 515.453-1403, by writing Multi-State Lottery Drawing Security Division, Multi-State Lottery Association, 4400 N.W. Persons attending drawings must show valid photo ID and be supervised by a member of the MUSL Security Division during the drawing. A request to attend the promotional drawing must be received by MUSL no later than 24 hours in advance of the drawing.

3. Winners must sign their non-winning Hot Lotto Sizzler ticket and attach it to the appropriate completed claim form and present it to the Member Lottery in which it was sold within thirty (30) days of the drawing to successfully claim their prize. In the event a prize winner is declared ineligible or fails to present the qualifying ticket or a fully executed claim form as required, the first drawn alternate prize winner from the alternates selected shall be declared the winner.

### **General Rules**

- 1. Players will be limited to winning only once in the promotion. If an entrant is selected to win more than one (1) prize, another winner for the second prize will be selected.
- 2. If more than one person's name appears on an entry drawn as a winner, these individuals will be notified, and it will be their responsibility to declare ownership of the prize.
- 3. Winner(s) will be notified via postal mail and/or phone of their winner status after all validation and verification has taken place. Winner(s) will be required to provide proof of age, identification and proof of ticket to the Oklahoma Lottery. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, <u>www.lottery.ok.gov</u>. If a winner does not meet all promotion qualifications (valid entry, age requirement, etc.) they will be disqualified and another entry will be selected and subsequently validated and verified.
- 4. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
- 5. Prizes pictured in game materials and on the Lottery website are for illustrative purposes only.
- 6. Only persons 18 years of age or older are eligible to enter and win. Winners will be required to furnish proof of age.
- 7. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
- 8. The MUSL and all member lotteries and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The Oklahoma Lottery is not responsible for entries that are late, misdirected or incomplete. All entries become the sole property of the Oklahoma Lottery and will not be returned. CAUTION: ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATIONS OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE OKLAHOMA

LOTTERY RESERVES THE RIGHT TO CANCEL THE PROMOTION IF IT BECOMES TECHNICALLY CORRUPTED.

- 9. Neither MUSL nor any Member Lottery shall be responsible or liable for:
  - a. Any damage to an entrant's computer system that is directly or indirectly caused by accessing or downloading content from any Member Lottery or MUSL website or otherwise by participation in this promotion;
  - b. Any computer system, phone line, hardware, software or program malfunctions that prevent entry into this promotion; or
  - c. Any other errors, failures, dropped or delayed computer transmissions or network connections that are human or technical in nature.
- 10. No other tickets or entries are eligible for this promotion, including Scratchers games, sample-void tickets, altered or stolen tickets, postcards, any canceled ticket or any likeness of an authentic ticket.
- 11. The Oklahoma Lottery is not responsible for any non-promotional mail inadvertently sent to the promotional address.
- 12. The Oklahoma Lottery will not provide any assurance and/or verification of receipt of any entry submitted by any player or promotion participant.
- 13. The Oklahoma Lottery makes no express or implied warranties of any kind with respect to the safety, appearance or performance of any prize offered.
- 14. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
- 15. This promotion and subsequent prizes are in addition to, not substitute to any and all prizes associated with the Powerball and Hot Lotto online games.
- 16. MUSL employees, Member Lottery board and commission members and employees and their immediate families, and any other person or entity otherwise prohibited from participation by the statutes, rules and/or regulations of any Member Lottery are not eligible to win a prize in this promotion.
- 17. Each person entering this promotion agrees by the act of participation to be bound by these Online Promotional Procedures of the Oklahoma Lottery.
- 18. These Online Promotional Procedures may be modified at any time at the sole discretion of the Oklahoma Lottery.
