Promotion Detail

Text LOTTOBONJOVI, to 44622 for a chance to win the specified prize.

Prizes

- 1. Five (5) winners will receive a Bon Jovi Prize Pack
 - a. Prize includes: (2) tickets to see Bon Jovi on March 16 and \$100 spending cash

Entry Submission Methods

1. Mobile Club Text Message: Players must text the short code LOTTOBONJOVI to 44622.

Promotional Considerations / Restrictions

- 1. Selected winners can only win one prize during this promotion.
- 2. Winners of Mobile Club promotions must be active members and be an Oklahoma resident in order to qualify to win the prize.

Drawing Information

The Prize Drawings will be held at the Oklahoma Lottery headquarters. Only the Drawing Manager, an Accounting Official and a Security Official will be present during the drawing. Drawing officials will access the entry database via the Oklahoma Lottery website. A computer-based random number generator will be used to execute the official drawing once the final range of entries is determined. For this drawing, a total of seventy-five (75) entries will be drawn from the online submissions to serve as twenty-five (25) prize winners and fifty (50) alternates. Of the selected entries, entries 1 through 25 will be awarded the prizes and entries 26 through 75 will serve as alternates in case a winner cannot claim their prize. The Oklahoma Lottery will make all best attempts to conduct daily drawings of winners.

The Drawing Manager will record the drawn ticket and entrant's information for all entries. Winner will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn for prize validation.

General Rules and Procedures

- 1. All prize winners must be 18 years or older. Winners will be required to provide proof of age and maybe required to show proof of purchase.
- 2. Winner(s) will be notified via phone/mail or email of their winning status using the contact information provided on the entry ticket/online submission. Final awarding of prize will take place after all validation processes have taken place.
- 3. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, www.lottery.ok.gov, and at authorized OLC retailers.

- 4. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
- 5. Prizes pictured on point-of-sale materials and on the Lottery website are for illustrative purposes only.
- 6. Winners of cash and merchandise prizes valued over \$600 will be issued a W2-G tax form. Cash prizes over \$5,000 are subject to federal and state tax withholdings at the time of prize awarding. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
- 7. The Oklahoma Lottery and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The Oklahoma Lottery is not responsible for entries that are late, misdirected or incomplete. All entries become the sole property of the Oklahoma Lottery and will not be returned. CAUTION: ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATIONS OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. - 8. The Oklahoma Lottery reserves the right to refuse admission of an entry or group of entries if it is determined that the submission has occurred under a pretense that does not conform to the above listed rules.
- 9. A minimum number of entries may be specified in order to qualify for an awarding of any or all of the prizes as described in the promotional procedures.
- 10. No other tickets or entries are eligible for this promotion, including other Scratcher games, sample-void tickets, altered or stolen tickets, postcards, any canceled ticket or any likeness of an authentic ticket.
- 11. The Oklahoma Lottery will not provide any assurance and/or verification of receipt of any entry submitted by any player or promotion participant.
