# **Entry Submission Methods**

# Mobile Club Text Message

Entrants must text the short code "LOTTOROGUE" to the number 44622 to enter. Entrant must be a valid and active member of the Oklahoma Lottery Mobile Club at the time of the drawing, must be 18 or older and an Oklahoma resident to be eligible to win a prize. If an entrant opts out of the Mobile Club any time during the promotional time frame their entry is no longer valid and will be disqualified if drawn as a winner or an alternate in the prize drawing.

# **Entry Period**

The entry period for this promotion is **November 7 to November 30, 2016**. Entrants will be eligible for the drawing after submitting LOTTOROGUE to 44622. LOTTOROGUE text must be received during the above promotion dates to qualify for this promotion.

### **Drawing Information**

The prize drawing will be held at the Oklahoma Lottery headquarters. During the drawing, only the drawing representative, security official and an accounting representative will be present. All submitted entries will be digitized and uniquely numbered for the official drawing. A computer based automated

drawing system will be used to execute the official drawing. For the drawing, a specified number of entries will be drawn to serve as winners and alternates to cover the total number of winners needed for the entry period. All other entries drawn will be assigned as alternates in the event a winner or winners cannot claim their prizes. Winners will be contacted by the Oklahoma Lottery for prize fulfillment purposes.

- 2. No cash value of the tickets or alternate date to attend movie is available for this promotion
- 3. Theater availability will be subject to when prize is claimed by winner
