**Entry Submission Methods**

**Oklahoma Lottery Website**

To enter, players must submit all of their contact information and the required codes from the designated ticket on the promotional web page located at [www.lottery.ok.gov](http://www.lottery.ok.gov). The age verification box must also be completed providing confirmation that the entry is being submitted by a person at least 18 years of age. Players must save their original entry ticket once it has been entered online and may be required to reproduce the ticket during the validation process. Failure to re-produce the required ticket can result in disqualification.

**Postal Mail**

An official entry consists of an entry ticket printed from an eligible purchase with information completed and mailed to the Oklahoma Lottery headquarters. A complete name, address, telephone number, email (optional), signature and checked age verification box must be provided on the entry. Entries must be submitted in an envelope. Multiple entries in an envelope will be accepted. Each entry will be valid throughout the duration of the promotion. The Oklahoma Lottery is not responsible for lost, late, misdirected, damaged, incomplete, altered, illegible or postage-due mail. Valid entries must be received

in the offices of the Oklahoma Lottery by end of day on the final day of the entry period to be included in the selection process.

### Deposit at OLC Headquarters

Players may enter the promotion by depositing their entries with the Claims Department at the Oklahoma Lottery Headquarters. Oklahoma Lottery employees cannot hand deliver entries given to them from any participating individual and any entry delivered in such manner will be disqualified.

### **Promotional Considerations / Restrictions**

1. Do not enter the promotion in more than one method for each ticket (e.g. mail and online entry submissions). Players found to be doing so can be disqualified from the current as well as subsequent promotions.
2. If you receive multiple entry tickets from one transaction that have the same transaction number, you will only be able to enter one of the tickets online and the remainder of the tickets will have to be entered through postal mail. Only one entry for each transaction number can be entered online per promotion.
3. Players may only win one prize per promotion, unless otherwise noted in the specific Promotion Procedures.
4. The Lottery will work with each winner to find the nearest Lowes for merchandise pick up. Delivery options will be the sole responsibility of the winner.

### **Drawing Information**

The Prize Drawings will be held at the Oklahoma Lottery Headquarters. Only the Drawing Manager, an Accounting Official and a Security Official will be present during the drawing.

Mailed-in entries will be counted and weighed in order to calculate the total (estimated) number of entries. The total number of mailed-in entries will be compared to the total number of online entries to determine the percentage of entries per category. There will be ten (10) semifinalists drawn in total. That number will be multiplied by the percentage of each entry category to determine the number to draw per category. A blindfolded employee (monitored by the drawing officials) will draw the required number from the mailed-in entries. The range of tickets for the online drawing will be entered into the Random Number Generator to determine the winners. The order of the semifinalist drawing will always be listed by online winners & alternates drawn followed by mailed-in winners and alternates drawn.

### Final Winner Drawing

Once the semifinalist entry order is determined, the range of winners and alternates (1-10) will be put into the Random Number Generator to determine the final winners. The Drawing Official will record all the information from the winning entries. Winners will be assigned prizes in the following order...

Winner #1	Kitchen Prize
Winner #2	Laundry Prize
Winner #3	Patio Prize
Winner #4	Garage Prize
Winner #5	Yard Prize
Winners #6-10	Alternates

Winner will then be contacted by the Oklahoma Lottery for prize fulfillment purposes. If there are not enough valid entries within the total that are drawn, an equal amount will be re-drawn and subsequently verified for validity.

### **General Rules and Procedures**

1. All prize winners must be 18 years or older. Winners will be required to provide proof of age and maybe required to show proof of purchase.
2. Winner(s) will be notified via phone/mail or email of their winning status using the contact information provided on the entry ticket/online submission. Final awarding of prize will take place after all validation processes have taken place.
3. By submitting an entry, each player authorizes the Oklahoma Lottery to release prize winner information to various media sources and list winners' names and pictures on the Oklahoma Lottery website, [www.lottery.ok.gov](http://www.lottery.ok.gov), and at authorized OLC retailers.
4. The Oklahoma Lottery reserves the right at its sole discretion to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.
5. Prizes pictured on point-of-sale materials and on the Lottery website are for illustrative purposes only.
6. Winners of cash and merchandise prizes valued over \$600 will be issued a W2-G tax form. Cash prizes over \$5,000 are subject to federal and state tax withholdings at the time of prize awarding. Additional local, state, federal or other taxes, expenses or surcharges associated with the prizes (if any) and not mentioned in these rules are the responsibility of the winner.
7. The Oklahoma Lottery and its agencies are not responsible for error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry, winner or other contest information by sponsors or entrants for any reason whatsoever. The Oklahoma Lottery is not responsible for entries that are late, misdirected or incomplete. All entries become the sole property of the Oklahoma Lottery and will not be returned. **CAUTION: ANY ATTEMPT BY AN ENTRANT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATIONS OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE OKLAHOMA LOTTERY RESERVES THE RIGHT TO CANCEL THE PROMOTION IF IT BECOMES TECHNICALLY CORRUPTED.**
8. The Oklahoma Lottery reserves the right to refuse admission of an entry or group of entries if it is determined that the submission has occurred under a pretense that does not conform to the above listed rules.

9. A minimum number of entries may be specified in order to qualify for an awarding of any or all of the prizes as described in the promotional procedures.
10. No other tickets or entries are eligible for this promotion, including other Scratchers games, sample-void tickets, altered or stolen tickets, postcards, any canceled ticket or any likeness of an authentic ticket.
11. The Oklahoma Lottery will not provide any assurance and/or verification of receipt of any entry submitted by any player or promotion participant.
12. The Oklahoma Lottery makes no express or implied warranties of any kind with respect to the safety, appearance or performance of any prize offered.
13. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
14. Each person entering this promotion agrees by the act of participation to be bound by these promotional procedures of the Oklahoma Lottery.
